Planning and Zoning Administrator Nick Fratzke presented to the Board two rezoning requests.

Motion by Talsma and seconded by Cupples to approve the Request for Rezoning made by David Ditzler of A&D Rentals, LLC on the following property: 13420 HWY 6 E, Oakland Acres, more specifically described as Tract 8 rods X 31 rods 13'6" SW COR SE SW EX N 155' and EX OAKLAND ACRES PLATS 1&2, Section 22, Township 80, Range 17, of the 5th P.M. containing approximately 1.37 acres. To be rezoned from "A" to "C" in order to allow a commercial storage unit facility to be operated.
