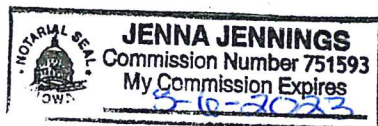

Part of the W 1/2 of the SE 1/4 of Section 18, Township 79 North, Range 19 West of the 5th P.M., Jasper County, Iowa, EXCEPT Commence 30 feet W of the NE corner of the NW 1/4 of the SE 1/4 of said Section 18, thence S 417 1/2 feet, thence W 313 1/8 feet, thence N 417 1/2 feet, thence E 313 1/8 feet to the place of beginning; AND EXCEPT Parcel A in the NW 1/4 of the SE 1/4 of said Section 18, as appears of record in Plat Book 1153, Page 409 in the Office of the Recorder of said County; AND ALSO EXCEPT Parcel B in the NW 1/4 of the SE 1/4 of said Section 18, as appears of record in Plat Book 1156, page 411, in the Office of the Recorder of said County.

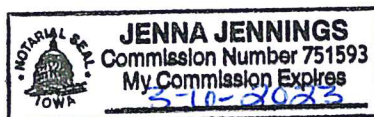
