DISCUSSION ITEMS:

A naturalist report was presented by Read.

Derecho Storm Update. Van Zante updated about damage that was done by the storm. Park cleanup projects are nearing completion, though some will take a while (roofs on houses, observatory roof and interior). Van Zante is working with insurance and FEMA to assist with funding.

CALVIN WINN MEMORIAL- ACTION 21-13. Kathy Winn brought in \$3,000 for Calvin's memorial. Van Zante discussed with her about recycling an old corncrib to create a shelter house at Uhlenhopp Arboretum. Kathy thought the project sounded perfect. The project will cost \$6-7,000 after pouring a floor for the shelter, moving the corn crib, and running electricity to the site. Motion by Freidman, second by Kramer to add up to an additional \$3,000 funding to complete the memorial project for Calvin Winn. Motion carried unanimously.

Audubon Society Property Offer. Bob Van Ersvelede, the president of the Tallgrass Audubon Society, sent a message to Van Zante asking if the Jasper County Conservation Board would be interested in taking Blue Point Woods in Poweshiek County, as a donated property. Board members were not interested

in managing a property in a different county, but suggested letting the Audubon group know that we would take the monetary donation if the group decided to sell Blue Point Woods.

REQUEST FOR SCOUTING EVENT AT KRUMM- ACTION 21-14. Mike Sokol troop leader from troop 313 in Grinnell, requested the use of Krumm Preserve on January 16 for a winter Klondike Derby event. Board members were supportive but asked Van Zante to make sure Sokol understood the park would still be open to other visitors. Scouts will need to pay for the \$200 special event permit, but will not be charged to use the shelter house or camp at the park. Motion by Kramer and second by Friedman to allow the Scout 313 Klondike Derby Event at Jacob Krumm Nature Preserve January 16, 2021. Motion carried unanimously.

Mariposa House. Cooling is gathering bids to replace the roof at the house at Mariposa. This project will be completed utilizing insurance money because it was damaged from the derecho.

Grants. The REAP grant was not successful (only 4 land acquisition projects were funded). The Prairie Meadows grant is next upcoming grant deadline. Board members suggested applying for the yurt project at Ashton.

Camping and Cabin Planning Review. Van Zante suggested thinking about the classroom at Sugar Creek as an overnight cabin. VanderPol has some design ideas he will share at a later date.

Nature Center. We will have the Caring for Conservation nature center auction as a virtual event on December 5 at 6:00 pm. Updates to follow at next meetings.

Other. Event this Saturday at Ashton Park: Jolly Howl-a-day Lights will be a drive through lighted Halloween/trick or treat event from 6-8 pm. Upcoming meetings will be held the 2nd Tuesday of the month beginning at 10:00 am.

Board Member Concerns. Nothing identified.
